## APPLICATION PROCESS FOR AOCRA OC1 USEAGE:

- 1. Applications must be made to AOCRA for use.
- 2. A written application to the AOCRA Secretary Pam Prescott <u>secretary@aocra.com.au</u>.
- 3. The AOCRA Management Committee will consider each request on application.
- 4. Written applications should include the following points:
  - a) Target group
  - b) Length of program, start and finish date
  - c) Coaches name and contacts
  - d) Storage arrangement of boats and storage address (must be stored undercover, out of sun tarps are not acceptable)
  - e) Signed agreement for the liability of loss or damage of any equipment loaned (<u>may</u> be limited to insurance excess)
- 5. Boats must be picked up, and returned by agreed date, at the cost of the loaner
- 6. Checklist of loaned equipment to be signed in and out.
- 7. Only AOCRA registered paddlers are to use OC1 canoes
- 8. Canoes are not to be used in surf conditions under any circumstances
- 9. AOCRA Safety Requirements must be adhered to at all times accessible PFD for each paddler, and leg rope in all circumstances other than sprint events.

## **CONDITION REPORT & AGREEMENT TO USE AOCRA OC1 CANOES:**

- 1. At delivery, and upon return, this condition report and agreement will be signed.
- 2. Canoes and trailer must be stored undercover, at the address as agreed to in the initial application (tarps are not acceptable)
- 3. If used by the zone/club, the zone/club agrees to return the canoes and trailer, and <u>all</u> associated equipment, in the same condition as they received them.
- 4. If repairs are required to be made, they may only be commenced after approval by AOCRA with a suitably qualified repairer. The zone/club agrees to reimburse AOCRA for any costs incurred in repairing or replacing the said equipment to the condition they were originally received by the zone/club. These costs <u>may</u> be limited to the insurance excess, however AOCRA may at its discretion, charge up to the full rectification costs, if the zone/club is found not to have adhered to this agreement.
- 5. Only AOCRA registered paddlers are to use OC1 canoes.
- 6. Canoes are not to be used in surf conditions under any circumstances
- 7. Senior canoe marshals are to be utilised at all times, for launching and retrieval of canoes from water when the canoes are being utilised by juniors.
- 8. AOCRA Safety Requirements must be adhered to at all times accessible PFD for each paddler, and leg rope in all circumstances other than sprint events.
- 9. After using the OC1 Canoes, all canoes must be thoroughly washed in fresh water.
- 10. Any vehicle towing the OC1 trailer must have adequate insurance coverage for 3<sup>rd</sup> party property. The driver of the said vehicle must comply with all current state road rules, and the zone/club will be liable for any fines or costs incurred for breaches of these road rules, including parking tickets, speeding fines etc.
