### **Race Rules and Safety**

All AOCRA rules and regulations will be enforced, as per the **AOCRA Rules** available under the Administration tab on the AOCRA website.

#### Please note:

- All V12 canoe paddlers must wear a lifejacket
- Each V12 shall have at least 2 bailers in each canoe.
- A safety boat (IRB) will follow the canoes down river on both days. A first aid kit, water and sunscreen will be on board for paddlers use. Some filming may occur for training and technique reviews by our senior coach.
- Please note it is the responsibility of all Club Coaches to ensure their crew participating in this event are capable of competing.
- Paddlers must be able to swim at least 50 metres to get to either river bank if necessary.
- Crews must be able to right a flipped canoe without assistance.
- Any crew finding themselves in trouble for whatever reason must raise their paddles in the air to alert support craft or passing canoe that assistance is needed.
- If at any stage of the even a safety official requests a canoe return to shore, all paddlers in the V12 must comply.
- The safety official my take such action as he/she/they deems necessary for the safety of the crews. Failure to complete with the above may invalidate your AOCRA insurance cover.
- There will be a designated first aid area on site and first aid response on the water.

The canoes will be left there overnight. Sunday will start at Cape Horn Winery and we will paddle to Victoria Park Boat Ramp (BBQ lunch provided).



### **Schedule of Events**



#### **SATURDAY 20th April**

8.30AM Everyone to meet at Victoria Park Boat Ramp. You will see the Inland Trailer near the ramp. For those coming from elsewhere on the day you may want to head straight to Barmah. Please let someone at IOCC know and arrive by 10.00am.

8.45AM All paddlers and drivers depart for Barmah

9.30AM Arrive at Barmah. Unload, rig and launch canoes and IRB. Car shuffle to take cars and trailers to Echuca

10.30AM Start Paddle

1.30PM Arrive at Cape Horn Winery (Collect bags with clothing etc from follow vehicle). Pizzas, Antipasto and drinks available at your cost. Cash and Card accepted.

Later: The Cape Horn Winery bus can transport people back to Vic Park Boat Ramp.

Please note: If you wish to be involved in the car pooling from Echuca please let IOCC know to assist with logistics.

Toilets are available at Barmah and Cape Horn Winery

Mud alert: Entry and exit from the river may be muddy & obviously wet. Prepare appropriately. A vehicle will follow the river road each day. You will need to put your bag in that vehicle ready to retrieve when you finish. A towel, dry clothes, shoes and recovery items recommended.

- 9.50AM Paddlers to start 2nd leg of paddle from Cape Horn. A support vehicle will be available to

put your gear in.

- 12.30PM Arrive at Vic Park Boat Ramp. De-rig, store canoes and load IRB
- 1.00PM BBQ/Soup etc at the finish Wrap up from IOCC. Leave for home.

## **Facilities on the Day**

Barmah - Toilets available

**Cape Horn Winery** - Pizzas, Antipasto board, Wine, Beer, Soft Drinks, Tea & Coffee and water.

tea and coffee etc. Toilets available at Cape Horn and Echuca information centre (site of

BBQ).





## **Trailer Parking**

Trailers used to transport canoes to Barmah will be returned to Echuca and securely parked on Saturday.

They can then be retrieved on Sunday to pack-up.

### **Transport Assistance**

Car pooling from Victoria Park Boat Ramp will be available both Saturday and Sunday to minimise the amount of vehicles going out to Barmah and Cape Horn Winery.

#### **Cancellation Policy**

AOCRA Refund Policy effective 30 November 2021 The Nomination Fee



AOCRA Refund Policy in the event of Postponement and or Cancellation

Refund policy may vary depending on the type of event and the Host or Organiser. The Host of each event must include a Refund Policy in the approved Regatta / Event Program outlining the terms for eligibility to request a refund. The Refund Policy must be the same wording as outlined in the AOCRA Rules, otherwise, the Host must seek approval from AOCRA Events for any changes prior to publishing a Refund Policy in the approved Regatta / Event program. The Refund Policy applies to nomination fees paid to enter a sanctioned AOCRA event only.

Nominee Cancellation Prior to the Event Date

Change of Mind or Unable to Attend

Once the nomination fee is paid there is no refund for change of mind. If you have paid the nomination fee and are unable to attend the event due to extenuating circumstances outside of your control, you may apply in writing using the AOCRA Request for Refund Form on the AOCRA website and email to <a href="mailto:support@aocra.com.au">support@aocra.com.au</a> giving details of the reason for requesting a refund. The Host, Zone and AOCRA are not obligated to refund their respective portions of the nomination fee, and if a refund is approved it will be processed in full less an administration fee of up to \$10 for processing the refund. AOCRA determines the administration fee at the time of processing a refund and retains the administration fee to cover their processing costs.

The nominee cannot request a refund on the day of the event or after the start date of the event.

Host Postpones or Cancels the Event

Host Giving Notice of Postponement or Cancellation

The Host must follow the AOCRA Rules to postpone or cancel an event and give notice in writing by: email, sms alert notification or text message to your mobile device, Host Facebook post, written announcement on the AOCRA website. The effective date is the date of dispatch.

**Event Postponed** 

Should the Host, Zone or AOCRA postpone an event, they are required to give notice at any time prior to the scheduled start time of an event.

A date for the rescheduled event must be announced within 7 days of the original event date in writing by: email, sms alert notification or text message to your mobile device, Host Facebook page, written announcement on the AOCRA website. The Host reserves the right to postpone the event (where no refund will be issued).

The rescheduled event program content / format may change including scheduled times which is at the discretion of the Host and they reserve the right to do without notice.

The Host, Zone or AOCRA may continue to postpone an event following the same process as above.

**Event Cancelled** 

The Host, Zone or AOCRA may cancel an event inline with the AOCRA Rules.

Cancellation more than 30 days before the event is at minimum a 80% refund of the Host, Zone and AOCRA portion of the nomination fee.

Cancellation more than 7 days before the event is at minimum an 70% refund of the Host, Zone and AOCRA portion of the nomination fee.

Cancellation more than 1 day before the event is at minimum a 60% refund of the Host, Zone and AOCRA portion of the nomination fee.

Cancellation on the day of the event is at minimum a 40% refund of the Host, Zone and AOCRA portion of the nomination fee.

The Host reserves the right to refund at a greater value of their portion of the nomination fee only, than the stated cancellation terms above.


The Zone reserves the right to refund at a greater value of their portion of the nomination fee only, than the stated cancellation terms above.

AOCRA reserves the right to refund at a greater value of their portion of the nomination fee only, than the stated cancellation terms above.

**Refund Payment** 

Refunds will be processed within 30 days of cancellation via the same method used for payment.
