Upon completion of the selection process, AOCRA will notify the successful candidate by phone and in writing.

The AOCRA Volunteer Agreement and NDA must be signed no later than three days (72 hours) from the written communication being sent. The appointment is not confirmed until receipt of signed agreement by both parties. AOCRA may appoint an alternate candidate if agreement is not received by the deadline.

If there are no candidates for the role, AOCRA may either re-post the opportunity or appoint an individual at their discretion.

If there is only one application by the due date, AOCRA reserves the right to seek additional candidates if they deem it necessary.

If more than one application is received by the due date, interviews will be conducted, and referees of the candidate may be contacted.
