

## AO2024 National Coaching and Education Framework

Question	Answer
What is the new framework known as?	The AO2024 Coaching & Education Framework
What is this new framework replacing?	Current Level 1 Coaching Certification Process
Why is the current L1 Coaching Certification being replaced?	To apply a graduated coaching framework where coaches can improve their knowledge skills and ability as a coach through Levels 1, 2 and 3, to provide a higher quality of service to our members
What are the key dates?	31 July 2024 – End of Old System 1 August 2024 – Start of transition to new scheme 31 October 2024 – End of 3 month transition period
What is the Transition Phase?	The 3 month period between 1 August to 31 October 2024 when coaches transition from the old Level 1 coaching accreditation program to the new National Coaching & Education Framework to ensure development of coaching capability and continuous support to our members.
What are currently active Level 1 Coaches (excluding any coaches sanctioned, restricted or with actions in place) required to do?	Nothing if they wish to remain within the parameters of the new AO2024 Level 1 Coach.
What can lapsed Level 1 coaches do to become accredited?	If recently lapsed they can apply through RPL/RCC/PPA process in a 6 month grace period to 31 January 2025 and show they meet the criteria and competencies for the AO2024 Level 1. If lapsed for longer than 18 months they can attend an AO2024 Level 1 course. Dates will be announced shortly.
What are currently active and accredited Level 1 Coaches who are recognised Club Head Coaches and wish to apply for Provisional Level 2 accreditation required to do?	The coach may apply for RPL/RCC/PPA to show they meet the current competencies listed for a Level 2 Coach. Contact their Zone Coaching Coordinator for documents to assist with this. A fee of \$150 accompanies this application to enable a sustainable mentoring program (note, the standard course fee of \$250 to attend a coaching course).
What are recognised Club Head Coaches who are in progress with their application ( with the National Coaching Manager) and attended	Coaches that have applied to be certified for the old Level 1 Coaching must complete their post course requirements and receive their certification prior to 1 November 2024 to become grandfathered to the new Level 1 accreditation.

the old Level 1 course post 1 November 2023 required to do?	If they cannot complete this in that time they may apply for a substantiated exemption for another 3 months to complete it and receive accreditation by 31 January 2025.
What are current Level 1 Coaches who are due to renew between 1 August 2024 – 1 November 2024 required to do?	Meet the criteria (complete the online courses etc) for the new AO2024 Level 1 re-accreditation checklist. Send evidence of completion to Zone Coaching Coordinators and they will forward to the National Coaching Manager for review and certification. Details will be published on the website.
Who are the current volunteers on the current Coaching Project and their purpose?	Janine Nikora, Caryn Scott, Jane Hall, Jenny Madden - To manage the rollout of the new National Coaching & Education Framework from Level 1 to Level 3 to ensure national consistency of content, integrity of assessment, appropriate messaging through good communication, clear policies and robust processes.
What are Zone Coaching Coordinators role and purpose?	<p>Assess the current coaching capability by club within their Zone to ensure all have accredited the AO2024 Level 1 &amp; ultimately Ao2024 Level 2 Coaches at appropriate levels for their club members.</p> <p>Coordinate coaching applications and renewals including notifications and follow up with the National Coaching team.</p> <p>Plan and organise Coaching Courses and Clinics for their region to meet demand. Utilise the approved AO Coaching Presenters in their region and at times invite interstate AO Coaching Presenters to co present. Plan and organise Coaching clinics to meet specific demand.</p> <p>Work with the Zone committee and National Coaching Team on initiatives as required. Provide a Coaching Report to Zone and National Coaching Team regularly.</p>
What are current AO Presenters role and purpose?	<p>To be familiar with and present nationally consistent coaching courses and to act as coach developers for new and aspiring coaches, while representing AO with integrity.</p> <p>Work with the Zone Coaching Coordinators and National Coaching Team in progressing new coaching applications.</p>
What is the National Coaching role and purpose?	<p>Lead, progress and maintain the new framework including delivering Level 2 Coaching Course curriculum and delivering Level 3 Coaching modules.</p> <p>Lead, progress and maintain the program of new AO Coaching Presenters and Coaches certification including renewals.</p> <p>Oversee the National Coaching Review Panel delivery of required outcomes.</p> <p>Monthly dashboard reporting on coaching statistics</p>
What is the National Coaching Review Panel?	<p>The National Coaching Review Panel assesses current AO2024 Level 1 Coaches:</p> <ul style="list-style-type: none"> <li>• for targeted Grandfathering to AO2024 Level 2</li> <li>• application to be assessed for AO2024 Level 2 competency</li> <li>• to identify and work with Head Coaches that are not eligible to be grandfathered to progress in meeting AO2024 Level 2 competency</li> </ul> <p>Work with the National Coaching Team to maintain the AOCRA National Coaching Register.</p>
