PROCESS TO QUALIFY

STAGE 1 - ONLINE ENTRIES BY DECEMBER 16TH

- Clubs will register teams and category/ies. Including V1 intents.
- Registration must be through **club.** Individual registrations will not be accepted.
- Individual names are not required at this time.
- These teams must nominate and compete at the AOCRA National Sprint Titles in February 2020.
- Only teams with intents submitted will be eligible to qualify for the 2020 World Club Championships.
- Paddlers must be members of the nominated club.
- The intent must be accompanied by the entry fee to the IVF World Club Championships. The fee is \$960per team (\$160 per paddler).
- This fee is only refundable if there are more than 6 teams that register an intent and your team does not qualify; or drops out before February 8th, 2020.

STAGE 2 - QUALIFY - BY FEBRUARY 8TH

- Teams must qualify at the National Sprint Titles held in February 2020.
- Team must qualify in 500m, 1000/1500 V6, straight and turn races and V12 races separately. This could mean that a team may qualify and then choose to go to World Club Championships to do one event only.
- After teams have qualified at National Sprints they have until 8th February to confirm their spot. If you intend to add reserves these will need to be notified and paid for by this date.
- V1 paddlers who qualified but are not part of a V6 team will need to pay \$160 nomination fee by this date.

VACANT SPOTS

- After 8th February, should a club choose not to take up their spot, then it will be offered to the next club with the next best time with an intent submitted. This club will have up until the 15th February to take up the vacant spot.
- Vacant spots after this time will be offered to a team that has already qualified. For example: maybe qualified for 500m straight but not 1000m turns.
- If a club qualifies, they have qualified a canoe. The paddlers may change but still must be a registered member of the qualifying club.

STAGE 3 - PADDLER NAMES & ID'S SUBMITTED

- Clubs must submit final names and confirm that all paddlers are members of that club by 1st May 2020.
- The following requirements apply to all ages. Current financial member of AOCRA and an affiliated club. Must be an Australian Citizen or Resident for at least 6 months before qualifying date (proof of ID will be required).
- Teams will be representing their Club and part of the Australian contingent and must wear matching club uniforms as per the IVF rules to compete.

PLEASE NOTE

As per IVF Rules only **three (3)** Elite team paddlers can paddle in any one V6 club team and **six (6)** Elite team paddlers can paddle in any V12 club team. V1 paddlers are **not included** in this quota.

Information regarding qualifying for Elite Australian representative teams (V6) will follow shortly. AOCRA board, coaches and selectors will endeavour to put our best teams forward with paddlers who are committed to the elite program.
